### • Brookfield Community Food Cupboard (Presentation is on website)

- Would be open Wednesday from 12-4 pm ish
  - 1 day a week
- 40-50% of students in the school are food insecure
- Hoping to open it this spring
- Chef from Lionsheart is helping
- Would like the HCCA to support
- Could also be a food drop off location

- o lain- Would it be open during the summer?
  - Yes it would but with different hours
- Melissa- Why isn't the food bank doing more?
  - The food bank operates through agencies, they are the supplier not the distributor
- Tania- Worked with Clementine Food Pantry housing organization. They use Second Harvest to help fill their pantry.
  - Will look into this and pass the information onto BCFC.
- Melissa- Would it be the same rules as the foodbank?
  - It might work on a points system but depends on the availability of food, aiming to start small and make it larger
- Brian- What does food recovery mean?
  - It is mostly food from large corps that they can no longer sell, It is not food that has gone bad

### Riverwood Park Pathway

- Document is on the website
- A nature walk in Riverwood Park, co-hosted by the HCCA and Ottawa Field Naturalists'
  Club will take place this spring (April 21). The walk will be led by Owen Clarkin, a noted
  tree expert, and all HCCA members are invited to participate. (Owen will also lead a
  walk in McCarthy Woods on April 20 as part of Earth Day celebrations hosted by the
  Councillor).
- The Environment Committee and the Affordable Housing Committee would like to share
  this document with the city and developer. It is asking for the approval from the HCCA to
  share its discussion paper regarding the proposed pathway in Riverwood Park. It also
  wants to advocate for adjustments to the route of the pathway to protect a number of
  "distinctive trees"
- City staff are getting close to high level approval of the St. Mary's plan of subdivision, including the preliminary design of the pathway
- Once date is established for a committee approval, this will pick up and move fast
- There are super healthy endangered Butternut trees in this stand that fall into the work impact zone and are thus at risk
- Super old yellow birch trees could be affected. This includes one that could be over 250 years old
- Rather large peachleaf willow- this could be the largest in Canada
- Question
  - a. Tania- Could the province overturn a decision to remove the endangered Butternut trees by using the species at risk act?
  - b. Answer: People/groups can appeal the planning decision, this is probably the best the city can get. The HCCA should submit the paper to the city and developer and see what happens. It is, however, very likely that the province will permit the removal of the trees.
