- c. Questions
 - i. Would a petition from the HCCA help with the Owl Park dog issue?
 - I would need to check with By-law on that issue.
 - ii. In what by-law does it state that a petition need to be presented to change the dog designation of a park
 - I'll look into it, but the manger of by-law says it's the case
 - iii. Is there any plan to fix the Sawmill Creek Pathway?
 - No currently, but will raise it with the city manger and the mayors team regarding the budget consultation soon. Will report back.
 - iv. Is there a plan to fix the "budget hole" that Ottawa currently finds itself in? Will the services be cut or will taxes be raised?
 - If the city doesn't get it's transit deficient under control and the feds don't pay their payment in lieu of taxes, the city doesn't have the reserves to fill the gaps, taxes will probably need to be raised.
 - Budget direction will be set next week, which will give a guidance on a possible tax increase
 - v. Would the cycle infrastructure in the transportation master plan be extended to the Tagart development or will it still end at Rivergate Way?
 - There is no current plan for the city to create cycle infrastructure from Hunt club to Uplands along Riverside. The plan is to connect Uplands to the Moneys Bay pathway. Will get it clarified tho.

6. Discussion Items

- a. Invitation to a Working Group to address 'How can people and dogs better coexist in our parks?
 - i. This issue is particular to Paul Landry Park.
 - ii. In 2019 a new sign stating that the park is dog off leash zone appeared
 - iii. Since then numerous safety and sanitary issues have come up.
 - iv. The intent of the motion is to serve as an indication from the HCCA membership regarding dogs co-existing with people in Paul Landry Park.
 - v. Motion: Whereas ...
 - children's safety is paramount at all times;
 - Section 44 of the City's Animal Care and Control By-law No. 2003-077 stipulates that "No owner of a dog shall have a dog on parkland, or any part thereof, where the dog is within five meters of a play structure;
 - there is a basketball play area and a play structure at Paul Landry Park;

 the lawn area adjacent to these play areas is is very small (approximately 1500 sq meters, or 0.15 hectares)

Be it moved that:

- The 'Dogs Off-Leash' designation be rescinded at Paul Landry Park
- 2. A new 'Dogs On-Leash' designation be established at Paul Landry Park.
- 3. Two new signs be installed at Paul Landry Park to clearly indicate the new 'Dogs On-Leash' designation, that would replace those indicating the 'Dogs Off-Leash' designation.
- A working group of interested community members be created to brainstorm and propose alternate/additional opportunities for dogs and people to better co-exist in our Hunt Club community.

vi. Question/comments

- Clarify that dogs are still allowed just on leash
- Cahill Park is a better park for dogs due to the large open space compared to Paul Landry
- Amendment to make a working group to establish alternation opportunities for dogs and people to co-exist in our Hunt Club Community
- Vii. Seconded by Peter. Passed.
- b. HCCA Membership and Governance Bylaw
 - i. Want to bring in the increase in membership fees
 - ii. Wants to clarify the bylaws about who can be a member, ie live or feel connected with the community.
 - iii. Wider membership, or board members only
 - iv. Question/comments
 - It might be good to include people just on the edges of the community
 - Could be putting ourselves at risk if outside people who care about whats going on, or with financial stakes could come in and out vote the people in the community
 - a. Could just restrict who can become a board member as they are the ones who vote
 - Could open ourselves to a hostile takeover
