6. Councillor's Report (Councillor Riley Brockington)

- a. Is posted on the website
- b. Questions
 - i. Does the plan for new development in McCarthy woods expand to the River?
 - NCC has not current plans to development any part of the woods but would need to double check
 - ii. Will reinforce with the new airport CEO the perks of community engagement and the need to consult the community
 - iii. Whats the reason some woods near the two condos on Riverside have been cleared?
 - Not sure but would need to look into it
 - iv. What was the reason for the senior hike for OC Transpo?
 - It was done to try to keep the level of service at it's current levels
 - City is also raising the cost of the U-Pass even though it's against their current contract with all the post secondary institutions
 - Trying to make the budget better even though I voted against it
 - v. Is the budget hole a play by the mayor to get help from the province or the feds?
 - Possibly. The feds or the province weren't going to provide any money without a budget first that shows the need and how they are trying to deal with the issue
 - vi. Was there any discussion about raising tax in the city budget?
 - This year it's 2.9% tax increase
 - City staff are given a directive by council not to exceed a certain amount of an increase
 - Appreciate for other tax increases such as water, transit, etc
 - vii. Issue of the school bus stop at Uplands and Paul Anka with cars not stopping for the bus
 - Will make the local police officer aware of this
 - Will look to see what measures could be taken with traffic calming
 - viii. Are the police horses in or out? Will the hole in the budget stand legally?
 - Horses are being funded by another level of government unsure if it's 100% covered
 - ix. Is the changes on McCarthy road finished or will more work occur?
 - At the moment yes.
